Oπicial Call for Nominations CWA Local 6001 Executive Board

This is your official notice that nominations are being accepted by CWA Local 6001 Election Committee for positions on the Executive Board of Local 6001.

- 1. DEADLINE for Nominations: September 1, 2020. (Must be returned to, Election Committee's P.O.Box to be valid.) Duties of the Executive Board are explained in our By-Laws. www.cwalocal6001.org, then click on the by-laws tab.
- 2. Members will be electing the following four officers and Area Reps:
 - a. President
 - b. Vice-President
 - c. Secretary
 - d. Treasurer
 - e. Area. Reps
 - i. Area 1: All members DFW Airport (two Area Reps) will be elected.
 - ii. Area 2: All members DFW RES, HBR/OBR (two Area Reps) will be elected.
 - iii. Area 3: All members in Premium Services.(one Area Rep) AUS,DFW,IAH,STL will be elected.
 - iv. Area 4: All members in Texas outside of DFW. (AUS, IAH, ELP, SAT) (one Area Rep) will be elected.
 - v. Area 5: All members in Missouri, Oklahoma, Kansas and Arkansas (MOKA)(one Area Rep) will be elected.
- 3. All nomination forms may be submitted without the nominees signature as long as at least one form is received that includes the nominees signature for each nominated position. The forms received will be reviewed by the Election Committee on September 1, 2020. The names of properly nominated candidates will be printed on official ballots and mailed to members. **ONLY MEMBERS IN GOOD STANDING IN THE UNION CAN NOMINATE OTHER MEMBERS AND VOTE**.
- 4. Nomination Procedure
 - a. Anyone wishing to be nominated for an Executive Board seat must be nominated by at least **five members** in good standing who are **eligible** to vote for that position.
 - b. Nominees, or those nominating them, must fully fill out a CWA Local 6001 Nomination Form. (Included)
 - c. The nominee must state that they are willing to accept the responsibility of the position if elected. The nomination form must be received in the Election Committee post office box by the nomination deadline (09:30AM-September 1, 2020).

- 5.TimeLine for Elections.
 - a. Deadline for Nominations: September 1, 2020, 09:30AM
 - b. Ballots mailed to members: September 15, 2020.
 - c. Deadline for Ballots to be received: October 6, 2020. 09:30AM
 - d. Runoff Ballots (if one) to be mailed October 13, 2020.
 - e. Runoff Ballot Deadline and Count: November 10, 2020. 09:30AM
- 6. Campaigning
 - a. Nominees are entitled to ask coworkers for their votes when both are off duty.
 - b. Campaigning must not interfere in any way with work. No campaigning in work areas. No campaigning during work hours except breaks in non-work areas.
 - c. No campaigning can be done at official union meetings, functions, or activities.
 - d. Candidates may produce and distribute campaign literature and materials. Such materials must be produced at the candidate's expense. No CWA or American Airlines symbols, logos or similar devices may be used in campaign literature.
 - e. Candidates are entitled to mail campaign materials to other members. Materials must be produced and mailed at the candidate's expense. Candidates shall provide the Election Committee with blank Avery 5160 labels for mailers. Contact the Election Committee for more information:

CWA Local 6001 Campaign Rules and Release Statement

- No campaigning on Sales Floor, Gates, Ticket Counters or other work areas. Candidates may campaign outside of work locations, in break rooms, cafeterias, before/after work or on days off. Both the candidate and the employee must NOT be on paid work time.
- Campaign literature may not include any logos of the union or the company. Literature may only be posted on "public" bulletin boards at work. (Boards that allow "for sale", items etc.) NO Posting of campaign literature on UNION or AA Bulletin Boards (work notices, etc.)
 - Harassment of candidates is not allowed.
- Campaigning on Company or Union sponsored Social Media is NOT allowed. This means no campaigning on Facebook sites like Committee@SRO or Association of Passenger Service Agents/CWA Local 6001 or any company or union sponsored sites. Facebook, Twitter, Etc.
- Campaign mailers will be at the candidate's expense. If you wish to mail out any campaign literature you will need to contact the Election Chair to set up a time to send the mailer. You will need to provide the local with Avery 5160 type mailing labels. All expenses are to be paid by the candidate(s) sending out materials, this includes reimbursement of any hourly wages of the election committee if on union paid time. The Election Committee will take the mailer to the post office to mail after all labels have been placed on envelopes. (Candidates may observe or send an observer but will not have access to personal information of the members.)

Persons convicted of "robbery, bribery, extortion, embezzlement, grand larceny, burglary, arson, violation

of narcotics laws, murder, rape, assault with intent to kill, assault which inflicts grievous bodily injury, a violation of Title II or III" of the act, and those convicted of abuse or misuse of their position or employment in a labor organization or employee benefit plan, are not eligible to hold office for thirteen years after conviction if there has been no imprisonment, or for thirteen years after the end of the period of imprisonment.
